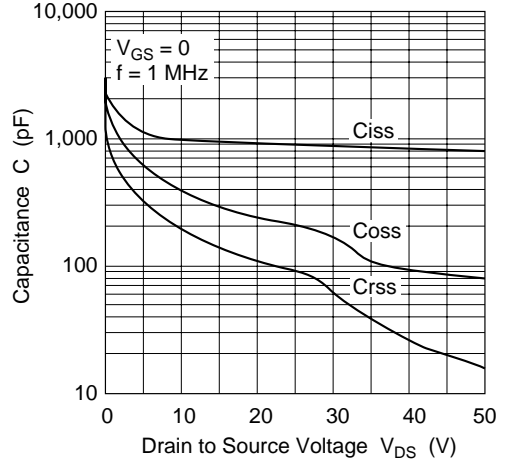




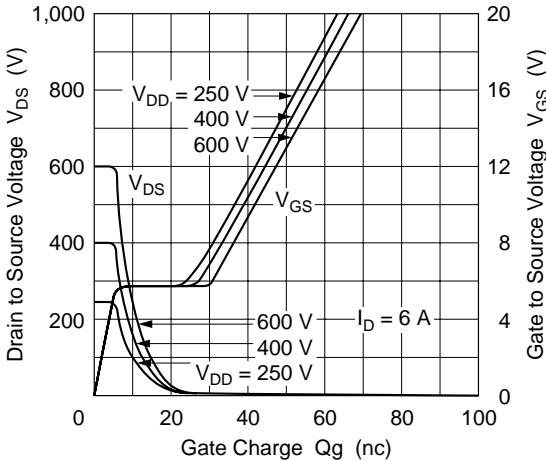
Body to Drain Diode Reverse Recovery Time



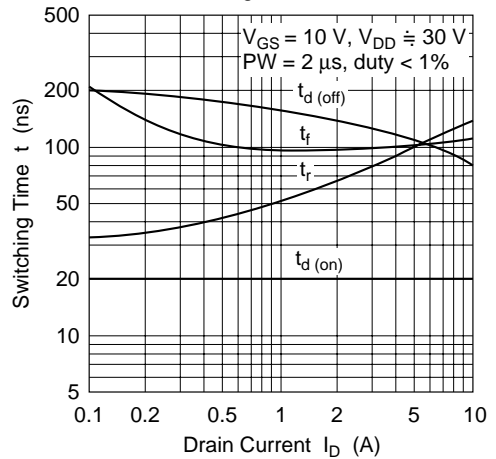
Typical Capacitance vs. Drain to Source Voltage



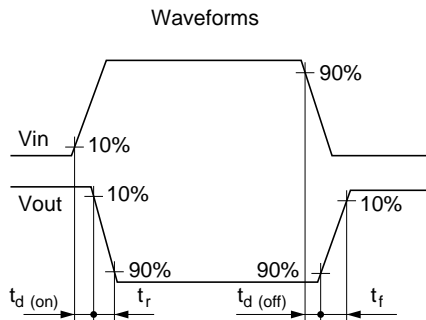
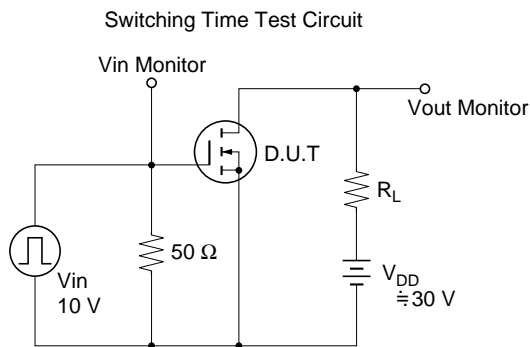
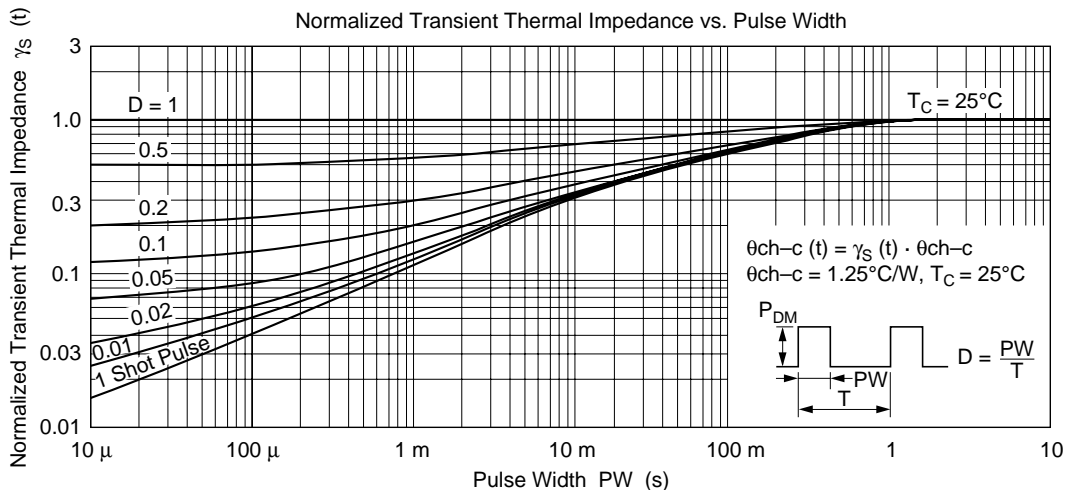
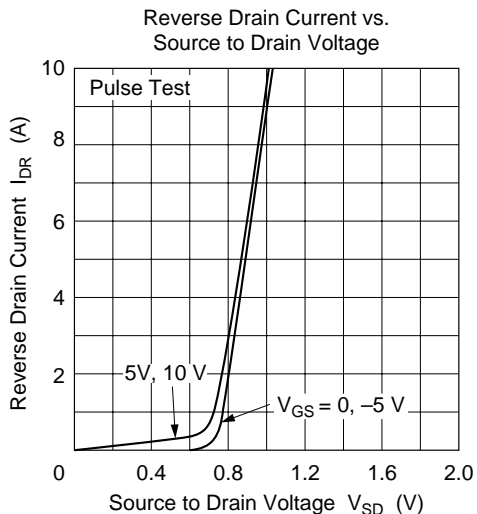
Dynamic Input Characteristics



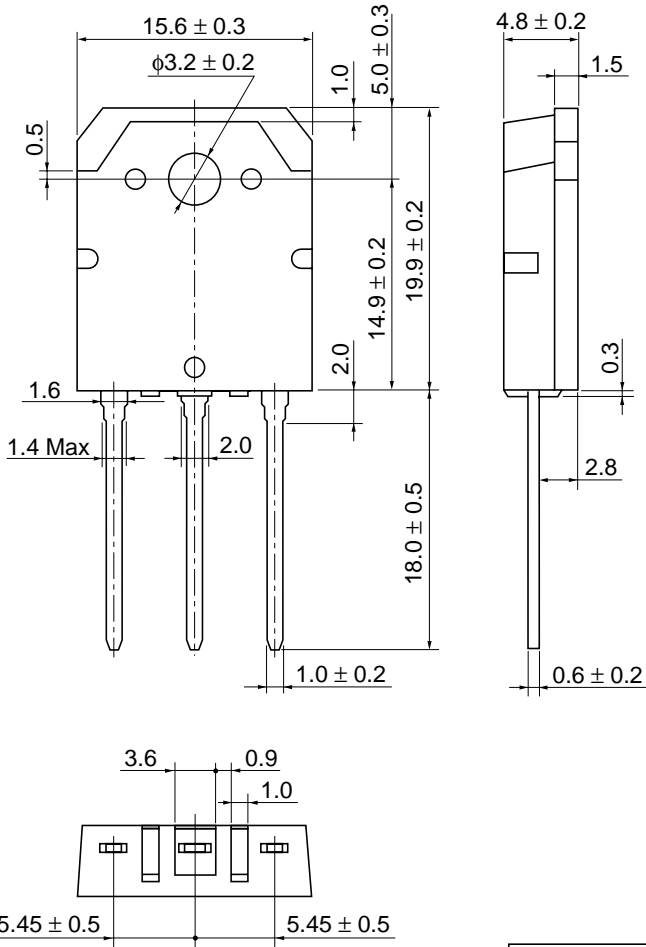
Switching Characteristics



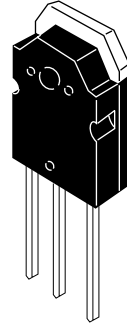
